## **ADDENDUM REGARDING** **PUNJAB STATE CIVIL SERVICES COMBINED COMPETITIVE** **EXAMINATION-2025**

1. In continuation to the advertisement no. 20251 dated 03/01/2025 issued by the Commission for recruitment to the ibid posts, it is for the information of all the candidates that the PPSC has received a fresh requisition from the Department of Personnel, Government of Punjab vide its letter no. 10/04/21-6PP3/575 dated 11/08/2025 and letter no. 10/04/21-6PP3/579 dated 12/08/2025 whereby the total number of vacancies has been increased from 322 to 331. All other category candidates cannot apply afresh as vacancies in their respective categories were already advertised earlier and they were given a fair chance to apply for these vacancies.

It is for the information of the candidates who have already been registered for the said exam i.e. who have completed the first and second step of online registration (means completely filled their online application form and have uploaded both their scanned photo and their signatures) before the closing date i.e. 31/01/2025 but due to some reasons were not able to pay the Fee, a link/window is being opened for them to pay their pending Fee from 03/09/2025 to 14/09/2025 till 11:59 PM. Such candidates won't be allowed to edit their application forms or upload their photo and signatures. They can only pay their Fee online. Fee link "ONLINE PAYMENT" is available on the homepage of the Commission's website.
